#### News and Views Straight From the County Agent's Desk

Howdy! It's been a while since we last visited and I want to personally apologize for that. Needless to say COVI19 has brought its many challenges at our office and the way we've



traditionally delivered educational programs. It's been different but has been good in many ways as it has forced us to learn new methods of how to deliver our programs.

One example is our RC Extension Staff "Grilling 101" educational program series. This program was a six week program in which we developed five educational videos related to improving summertime grilling experience. Each video focused on a different outdoor grilling topic. These topics included: Introduction to Path to Plate; Meat Preparation/ Marinades/and Food Safety; Meat Cut Selection; Types of Grills and Special Features; Preparing Your Grill/Proper Temp and Tips for Avoiding Cross Contamination. Each week a door prizewas provided to a selected viewer that had commented on the previous weeks video.

The series concluded with a grand prize drawing. A total of 33 RC Employees (target audience) participated and 19 evaluation responses were received. This program proved to be very successful. Clientele can be looking for more Extension programs to be delivered through this method in the future.

#### **Current Crop Conditions**

DRY has been the common theme for agriculture production so far for this year's entire crop season. According to the National Weather Service Randall County has revived only 8.38 inches of rain fall thus far for 2020. As we compare



that to 2019, we had received just a little over 22.9 inches up to this point. Therefore this puts us 14.52 inches behind from where we were this time last year. All crop harvest yields much lower this year due to the extreme dry conditions throughout the growing season.

Corn/Silage: Silage-Corn harvested was lower this year. Yield reports indicated corn yielding around 130-140 bushels per acre across the board.

Cotton: Just as we've been re-

porting all year with the drought this season cotton yields across Randall County were lower as well. Minimal dryland acres were harvested and at best perhaps only yielding 1/2 bale per acre. Irrigated acres were around 2 bales per acre to slightly higher.

**Sorghum:** Sugar Cane Aphid infestations were a concern again this year across Randall County fields. As in the past and once again this year, SCA populations increased late season and cause damage late season. Minimal dryland sorghum acres reached harvest with irrigated acres averaging around 3,000 lbs. per acre.

#### Pesticide Applicators Training/CEU Opportunities

We know that during late fall and early spring is the best time for many producers and workers to obtain their Texas Department of Agriculture Private Pesticide License.

The first thing you need to do is go through the Texas A&M AgriLife Extension Service training program. However during this time we are unable to offer face-to-face training. So we encourage you to take advantage of the online option. Here is the link for this online course:

All TDA Pesticide Applicator Courses offered on-line may be taken at any time based on your convenience. Available courses require you to self register on-line and pay all necessary course fees. and Laws and Regs.). At the conclusion of the course, be sure to print a certificate of completion and maintain a copy in your personal record file. *This is the ONLY way you can prove you have taken any of the on-line courses!* Hopefully, AgriLife will be able to host face-to-face meetings again real soon.

#### 2020 Hemp Variety Testing Wrap-Up & 2021 Trials

The following information is provided by Dr. Calvin Trostle, Texas A&M AgriLife Extension Agronomist& Hemp Specialist— Lubbock Texas

Hemp variety trial results at San Angelo (cannabinoids) and Lubbock (cannabinoids and fiber) will be completed shortly after the first of the year. Dr. Trostle will provide detailed results in my January hemp newsletter. Results will also be posted at <a href="http://varietytesting.tamu.edu/hemp/">http://varietytesting.tamu.edu/hemp/</a> AgriLife will update program information for the 2021 round of variety trials in January. In addition to test sites offered in 2020 (Lubbock,

San Angelo, College Station, Commerce), at least one additional fee-based test site will be offered in South Texas mostly likely Weslaco in the Lower Rio Grande Valley. Major Concern from 2020 Texas Hemp Cropping was heat impact that affected much of the Texas hemp crop. The scientific and commercial literature on hemp suggest optimum growing conditions are 70 to 80° F. So, most Texas hemp this year routinely experienced temperatures 20° warmer. Some of this was due to later planting. Dr. Tostel estimate the typical



field of Texas hemp in 2021 will be planted up to two months earlier than in 2020.

## Caution Tips with Prussic Acid/Nitrate Poisoning when Grazing Forage Sorghums

Concern is with any stressed forage crop situation (i.e. drought, hail, freeze). Johnsongrass is a major host as well.



⇒ Raising hay cutting bar 8-10 inches in any potential hot

field will help lower risk, but not eliminate possibilities.

- ⇒ Causes severe respiratory issues and likely death in cattle
- ⇒ Testing is the only assured way to know if there is toxic levels present. Take test in center of bale with hay probe. Serv-Tech Lab, Amarillo (806) 677-0093.
